Deposits

A \$500 per person non-refundable deposit is required at the time of booking, payable within seven days of reservation confirmation. The balance is due by August 1, 2017. For tours booked less than 90 days in advance of tour, full payment is required at the time of reservation. Should the tour not occur, the deposit will be refunded.

Cancellations and Refunds

If we receive written notice of your cancellation 61 days or more from the start of the tour, your fees will be refunded less the \$500 deposit. There will be no refund for cancellations made 60 days or less from the start of the tour. Exceptions to this cancellation policy cannot be made for any reason, including personal emergencies. There are no refunds for any part of the program that you choose to opt out of.

We reserve the right to cancel any tour prior to its start, in which case all monies received will be refunded, including the deposit. Once you have booked your trip, we strongly recommend purchasing travel insurance (including trip delay, trip interruption, trip cancellation and baggage coverage), as well as accident, medical and emergency evacuation insurance. It is important to purchase this insurance shortly after booking the tour.

Should changes in the US government policies to Cuba cancel the tour prior to its start, all monies received will be refunded, including the deposit. Exceptions to this are any monies spent on non refundable tickets/lodging deposits already purchased.

Responsibility and Release of Liability

There are always risks associated with travel. We strongly recommend that you purchase trip and medical/evacuation insurance. Small Footprint Travels, LLC assumes no responsibility for any claim of damages, expenses or liability for any claims, injury, delay, inconvenience, irregularity, loss or damage to person or property or additional costs resulting directly or indirectly from causes that include, but are not limited to, theft, acts of government, delays, cancellations, weather, vehicle problems or accidents, strikes, illness, quarantine, acts of terrorism or "Acts of God" incurred during the tour including during

transportation by car, van, boat or other conveyance. Participants agree that Small Footprint Travels, LLC reserves the right to alter an itinerary or accommodations. The company also reserves the right to cancel a tour. Should that occur, Small Footprint Travels, LLC's liability would be limited to a full refund of the reservation deposit and/or fees paid, or to offer an alternate tour date. Small Footprint Travels, LLC reserves the right to decline to accept any person at any time should that person's health, physical infirmity or mental condition impede the health, welfare or enjoyment of other participants.

The undersigned recognizes that there is a moderate level of physical activity involved in the tour and the tour may require participants to walk long distances and climb stairs. The undersigned accepts any risks thereof and the conditions set forth therein. The undersigned also understands and hereby agrees for and on behalf of himself/herself, his/her dependents, heirs, executors, administrators, and assigns to abide by the conditions set forth and to release and hold harmless Small Footprint Travels and any of their officers or representatives from any and all liability for delays, injuries or death, or for the loss of or damage to, his/her property however occurring during any portion of the program.
